A-1 Fire Marshal/Public Safety Officer's Report – October 2023

Mr. Smith read the Fire Marshal/Public Safety Officer's Report for October 2023 into the record.

Mr. Smith informed Council that after speaking with the County Health Department, he is now a liaison between the County Health Department and the Borough. He provided the following issues/resolutions.

10/16/23 – A follow-up inspection for Family Dollar was performed. They had been shut down due to overcrowding of the rear storage space and animal droppings. The storage area was cleared out and reconfigured. The developer for the Upland Shopping Center, Nate Seaman, is in talks with Family Dollar about adding an extension off the back of the building to increase their storage space.

10/19/23 – Sam & Sam's had a complaint inspection (someone directly contacted the County Health Department to file a complaint). This complaint was cleared.

10/27/23 – Sam & Sam's had a follow-up inspection.

A-2 Fire Company's Report – October 2023

A-5 Motion to Accept and Adopt the <u>Second</u> Reading of the 2024 Proposed Auburn Village Budget, Income: \$899,160; Expenditures: \$899,160

A-6 Motion to Purchase Candy Canes for the Fire Company/Santa – Total \$193.50

15. Community Affairs – Moira Crawford

Events Held Since Last Council Meeting:

Annual Halloween Parade – This event was rescheduled to October 29, 2023 in order for the Upland Fire Company to participate. Approximately 600 goodie bags were distributed to the children. Ms. Crawford again thanked the Upland Fire Department and Upland Police Department for their participation.

Annual Seniors Free Thanksgiving Dinner – This event was held on November 4, 2023 at MacQueen Hall and served approximately 75 dinners. The number of attendees was smaller than in past years, but higher than during COVID.

Designer Bag Bingo Fundraiser – This event was held on November 11, 2023 and raised approximately \$5,000.00 before costs.

Last Event to be Held by Upland Community Affairs Association for 2023:

Annual Tree Lighting Ceremony – This event is scheduled for Friday – November 24, 2023 at Main Street and Castle Avenue. There will be the tree lighting with Santa after which, Santa will make another appearance at the Pavilion in Bristol Lord Field. He will have gifts for Borough children 13 and under that have signed up in advance. NOTE: Gifts must be picked up at the event.

President Peterson asked if all community events are listed on the Borough website. Ms. Crawford stated that they are on the calendar and under the events section.

President Peterson said that someone call 911 to find out what time the Bingo started. Ms. Crawford responded that Bingo was also advertised on the sign at 6th and Main Streets. She added that a phone call went out about this event.

CDBG 2022 & 2023 – The plans and specifications for the Main Street wall restoration have been prepared and the project was advertised for bid. Two bids were received. The low bid was from Premier Building Restoration of Erdenheim, PA in the amount of \$144,595.00. The second bid was from Schneider Restoration Inc. in the amount of \$287,600.00. Mr. Archdeacon recommended award to Premier Building Restoration in the amount of \$144,595.00.

A-1 Motion to Approve Bid Minutes and Bid Award for Main Street Wall Restoration

Ms. Crawford made a motion to authorize a donation to the Upland Senior Citizens' Club in the amount of \$400.00. Mrs. Kerns seconded the motion. President Peterson asked if there were any questions. Hearing none, Council voted Aye on the motion – no Nays – Mr. Bloom abstained. Motion carries.

A-4 Discussion on Donations to Private Sector Organizations

Ms. Crawford made a motion to donate \$6,000.00 to the Upland Baptist Food Bank. Mrs. Bush seconded the motion. President Peterson asked if there were any questions. Hearing none, Council unanimously voted Aye on the motion – no Nays. Motion carries.

A-5 Motion to Cancel the 2nd Meeting of the Month (11/28/23)

Ms. Crawford made a motion to cancel the second meeting of the month, November 28, 2023. Mrs. Bush seconded the motion. All Council verbally voted Aye; no Nays.

A-6 Motion to Approve the 2024 Calendar for Printing

Ms. Crawford made a motion to approve the 2024 calendar for printing. Ms. Gertner seconded the motion. Council unanimously voted Aye on the motion – no Nays. Motion carries.

23. Floor Open to Public

Mr. Smith addressed Council concerning Adam Hart. Adam was 16 years old when he joined the Upland Fire Company. After graduating high school, he went into the military career of a fire fighter. A few weeks ago, Adam lost his life in the line of duty at the age of 38. He was a member of the Upland Fire Company for 22 years. The military accepted this service and promoted him to a 20 year rank through the military. The Upland Fire Company will have a memorial for Adam on December 16, 2023.

Due to the memorial for Adam, the day Santa rides through the Borough will be changed to December 9, 2023.
