Mr. Catania announced the start of the bid opening for the 2010 Road Program and the 2011 Ford F-450 truck.

Mr. Catania began with the 2010 street improvements and the first bid which was from A.F. Damon of Upland, PA with a bid bond for 10% of the bid. The total bid is in the amount \$ 56,535.00.

The second bid from Innovative Construction from Folcroft, PA with a bid bond for 10% of the bid. The total bid is in the amount of \$ 57,900.00.

The third bid is from Kehoe Construction from Bridgeport, PA with a bid bond for 10% of the bid. The total bid is in the amount of \$ 79,570.00.

The fourth bid from Peoples & Son, LLC of Chester was disqualified as there was no bid bond.

The final bid was from Joseph E. Sucher & Sons from Eddystone, PA with a bid bond for 10% of the bid. The total bid is in the amount of \$ 72,004.00.

The second set of bids for the 2011 Ford truck began with a bid from Winner Ford in Cherry Hill, NJ with a bid bond in the amount of 10% of the bid. The total amount of the bid is \$ 44,440.00. The delivery is 112 – 150 days with exceptions taken and listed.

The second bid is from Hondro Ford from Manheim, PA with a bid bond for 10% of the bid. The total amount of the bid is in the amount of \$ 44,778.00 with a Western Plow and \$ 45,978.00 for a Fisher Plow and there are attached exceptions.

The third bid is from Brian Hoskins Ford from Coatesville, PA with a bid bond in the amount of 10% of the bid. The total amount of the bid is in the amount of \$ 43,500.00 with delivery of approximately 90 days. For a Boss plow deduct \$ 300.00 and there are exceptions included.

The final bid is from Fred Beans Ford from West Chester, PA with a bid bond for 10% of the bid. The total amount of the bid is \$ 44,219.00 with exceptions attached.

Mr. Catania thanked everyone who participated, and stated the bids will be referred to Council to be reviewed at the next Council meeting to be held on May 11, 2010.
