**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF UPLAND,
DELAWARE COUNTY, PENNSYLVANIA**

**BE IT RESOLVED BY THE COUNCIL OF THE BOROUGH OF UPLAND
AND IT IS HEREBY RESOLVED THAT:**

WHEREAS, the Council wishes, to update the “Upland Borough Comprehensive Fee Schedule” to accurately represent borough information concerning ordained and appropriate fees and charges which will enable more convenient administration of borough business and citizen access to this information; and

WHEREAS, the Upland Borough Council desires to adopt a Resolution establishing said updated Schedule of Fees for permits, licenses, and other ordained and appropriate borough fees and charges;

NOW, BE IT RESOLVED AND ENACTED by the Council of the Borough of Upland, Delaware County, Pennsylvania, and it is hereby resolved that; the following Upland Borough Comprehensive Fee Schedule to be paid to the Borough upon submission of an application for any permit or license, and for other identified charges by the Borough in accordance with the codified ordinances of the Borough of Upland is hereby created and adopted, and shall remain in effect until updated by future resolution(s) of Borough Council:

FEES

1. **BUILDING PERMIT FEES**

Note: *In addition to the fees below, all UCC building and construction permits will include a State \$4.00 administrative and enforcement fee as required by ACT 13 of 2004, payable to the Borough of Upland.*

Any UCC appeal fee is \$500.00.

Building, Mechanical, Electrical and Plumbing Permit Fees are as follows:

- All Permit Fees:
 - \$50.00 per \$1,000.00 of work performed
 - Plan Reviews: \$95.00 per hour
 - Accessibility inspections: \$126.00 per Hour

Note: *1) Additional inspections and any required re-inspections shall be completed at the cost of \$80.00, at the discretion of the inspector.*

2) Where any work, for which a permit is required by the Upland Borough Codes, is started prior to obtaining said required permit, the fees set forth in the codes for such permit shall be doubled as per §140-17A.

2. **CRAFTSMEN LICENSE AND CERTIFICATION FEES**

3. **STREET OPENING PERMIT FEES**

As per Upland Code §158-26

- Up to one-hundred (100) feet longitudinal excavation \$10.00
- Over one-hundred feet (or part thereof) \$ 5.00 per additional
linear foot

NOTE: *1) All fees and costs incurred by the borough, for work performed by the Borough Engineer pursuant to the provisions of any street opening, shall be borne solely by the applicant and shall be paid promptly upon presentation*

of a bill by the borough. Said payment shall be in addition to the fees required above. If said bill is not promptly paid by the applicant, the borough may revoke the permit in question until said bill is paid. The fees set forth above are to cover the costs of inspections by employees of the borough other than the Borough Engineer.

4. DEMOLITION PERMIT FEES

Buildings and structures as follows: *As per Resolution No. 1 of 2012*

- Residential Permit Fee:
\$50.00 per \$1,000.00 of work performed
- Commercial Permit Fee:
\$75.00 per \$1,000.00 of work performed

5. CONTRACTOR BUSINESS LICENSE FEES

As per Upland Code §60-9

For any and all contractors doing business within the corporate limits of the Borough of Upland:

- All contractors - flat fee of \$100.00 per calendar year

6. USE AND OCCUPANCY (U&O) INSPECTION FEES

As per Upland Code §69-5

Note: 1) The seller and/or the buyer of the property escrows with the Borough of Upland at the time of settlement an amount of money which, in the judgment of the Building Code Official, is sufficient to pay at least one-third (1/3) of the costs of the required repairs. The form of the escrow agreement shall give the Borough of Upland the authority to seize the monies from the escrow account if the owner has not completed the repairs within 18 months of settlement. * The Borough of Upland shall be entitled to impose a reasonable administrative fee for the preparation of the escrow agreement and the establishment of the separate escrow account.

2) At the end of the eighteen-month period, the Borough of Upland shall have the right to re-inspect the applicant's property. If at the time of said re-inspection the applicant's property continues to have one or more substantial violations, as determined by the Building Code Official for the Borough of Upland, then the applicant shall forfeit her or his escrow monies and shall be subject to liability to the Borough of Upland for fines and/or penalties as further set forth in the Upland Borough Code.

Note: 1) *In addition to the fee schedule above, all engineering costs and/or legal costs associated with reviewing the subdivision or land use development plan shall be paid by the applicant (subdivider/developer) to the Borough of Upland.*

2) *The applicant (subdivider/developer) shall also pay the Borough of Upland for all costs for inspection of utilities and/or improvements for the subdivision or land use development.*

3) *Any person, partnership, corporation or other entity initiating any such action(s) shall pay the applicable fee(s) to the Borough of Upland at the time such action(s) is initiated.*


