ATTENDANCE

Elizabeth Catania, P.E., F.NSPE, Borough Engineer, Greg Grillone, Borough Manager and two (2) contractors.

Ms. Catania introduced herself and Mr. Grillone to the audience as well as stating that bids for projects on today's agenda have been duly advertised in the Chester Spirit for the New 2017 Police Motorcycle, Trash Collection for years 2017 – 2022 and the Re-Bidding of the CDBG Project of the Retaining Wall at Sixth & Main Streets.

Ms. Catania began with **Trash Collection bids for Year 2017-2022.**

- The first bid was by B&L Disposal Services, Wallingford, PA. There is a bid bond in the amount of 5% of the bid. B&L Disposal Services offered:

Year One (1): \$ 97,035.00  
Year Two (2): \$ 100,020.00  
Year Three (3): \$ 103,035.00  
Year Four (4): \$ 106,055.00  
Year Five (5): \$ 109,165.00

Ms. Catania stated the amounts for each year included the recycling and special bulk pickup. Ms. Catania repeated the bid amounts from B&L Disposal Services, Wallingford, PA.

- The second bid was from H&H Disposal Services, Sharon Hill, PA. There is a bid bond in the amount of 5% of the bid. H&H Disposal Services offered:

Year One (1): \$ 135,000.00  
Year Two (2): \$ 135,000.00  
Year Three (3): \$ 144,000.00  
Year Four (4): \$ 153,000.00  
Year Five (5): \$ 162,000.00

Ms. Catania stated the amounts for each year included the recycling and special bulk pickup. Ms. Catania repeated the bid amounts from H&L Disposal Services, Sharon Hill, PA.

- The last bid was from JP Mascaro and Sons, Audubon, PA. There is a bond in the amount of \$ 250.00. JP Mascaro and Sons offered:

Year Three (3): \$ 155,952.00

Year Five (5): \$ 163,980.00

Year Three (3): \$ 40,812.00  
Year Four (4): \$ 41,652.00  
Year Five (5): \$ 42,564.00

Ms. Catania repeated the amounts for each year for regular trash and bulk trash as well as for the recycling from JP Mascaro and Sons, Audubon, PA.

**Re-Bid CDBG Project Retaining Wall Construction at Sixth and Main Streets**

Ms. Catania stated there was only one (1) bid received for the Retaining Wall from JMC Contractors, Glen Mills, PA.

- JMC Contractors, Glen Mills, PA offered the bid in the amount of \$ 74,600.00 with a bid bond in the amount of 10%.

**New 2017 Police Motorcycle – no bids received.**
