Mrs. Peterson announced the start of the bid opening for the Auburn Village Homes Concrete Replacement and Rail Painting.

Mrs. Peterson then turned the bid opening over to Mr. Charles Catania, Sr., P.E.

The first bid is from ARK Builders from Brooklyn, NY with a bid bond in the amount 10% of the bid. The total bid is in the amount of \$ 39,500.00; alternate # 1 in the amount of \$ 34.00 and alternate # 2 is \$ 700.00 flat fee.

The second bid is from Cleaver Construction from Glenolden, PA with a bid bond in the amount of 10% of the bid. The total bid is in the amount of \$ 74,105.00; alternate # 1 in the amount of \$ 30.00 and alternate # 2 is in the amount of \$ 25.00.

The third bid is from Ellis Construction from Glen Mills with a bid bond in the amount of 10% of the bid. The total bid is \$ 34,900.00; alternate # 1 \$ 10.00 and alternate # 2 is in the amount of \$ 90.00.

The fourth bid is from Ernel Company from Aston, PA with a bid bond in the amount of 10% of the bid. The total bid is for \$ 49,500.00; alternate #1 is \$ 15.00 and alternate # 2 in in the amount of \$ 750.00 flat fee.

The fifth bid is from JMC Contractors from Glen Mills, PA with a bid bond in the amount of 10% of the bid. The total amount of the bid is for \$ 64,400.00; alternate # 1 is \$ 15.00 and alternate # 2 is \$ 500.00 flat fee.

The sixth bid is from Moore Outdoor Rejuvenation with a bid bond in the amount of 10% of the bid. The total amount of the bid is for \$ 53,050.00; alternate # 1 is \$ 12.00 and alternate # 2 is \$ 2,500.00 flat fee.

The final bid is from Premier Concrete from Broomall, PA with a bid bond in the amount of 10% of the bid. The total amount of the bid is for \$ 42,000.00; alternate # 1 is \$ 15.00 and alternate # 2 is \$ 175.00.
