A. The Bid Opening began at 10:00 a.m. Present were Mr. Charles Catania, Sr., P.E, Vice President of Council, Mrs. Christine Peterson and Mrs. Shirley Purcival, Borough Manager.

Mrs. Peterson opened the meeting by welcoming everyone to the Upland Borough's June 30th bid opening for trash collection.

The first bid was from B & L Disposal Services from Wallingford, PA who presented a check in the amount of \$ 250.00 for the bid bond. The bids are for the year 2012 through 2016. For trash and garbage, year one is \$ 75,480.00, year two is \$ 76,989.60, year three is \$ 79,299.28, year four is \$ 82,471.25 and year five is \$ 86,595.70.

The amounts for recycling are for year one \$ 6,024.00, year two, \$ 6,144.78, year three, \$ 6,323.00, year four, \$ 6,512.86 and year five \$ 6,838.50.

The amounts for bulk waste are for year one, \$ 8,376.00, year two, \$ 8,543.52, year three, \$ 8,799.83, year four, \$ 9,151.82, year five \$ 9,609.41.

The second bid was from Laxton Enterprises from Glen Riddle, PA with a bid bond in the amount of 5% of the bid. The bids are for the year 2012 through 2016. For trash and garbage, year one, \$ 114,480.00, year two, \$ 118,656.00, year three, \$ 122,256.00, year four, \$ 125,856.00 and year five \$ 140,400.00.

The amounts for recycling for year one through five are included in the above bid amounts and bulk waste collection amounts for year one through five are also included in the above.

The third bid is from J.P. Mascaro & Sons (Solid Waste Services) from Audubon, PA with a bid bond in the amount of \$ 250.00. The bids are for the year 2012 through 2016. For trash and garbage, year one, \$ 146,736.00, year two, \$ 151,200.00, year three, \$ 155,796.00, year four, \$ 160, 416.00 and year five \$ 165,168.00.

Recycling bids for year one, \$ 34,092.00, year two, \$ 35,112.00, year three, \$ 36,360.00, year four, \$ 37,452.00 and year five \$ 38,640.00.

Bulk waste collection amounts for year one through five are included with the trash amounts quoted.

The fourth bid is from Suburban Waste Services from Wilmington, DE with a bid bond for 5% of the bid. The bids are for the year 2012 through 2016. For trash and garbage, year one, \$ 142,000.00, year two, \$ 142,000.00, year three, \$ 146,260.00, year four, \$ 150,647.00 and year five \$ 155,166.00.

The amounts for recycling for year one through five are included in the above bid amounts and bulk waste collection amounts for year one through five are also included in the above.

The final bid was from Waste Management from Langhorne, PA with a bid bond in the amount of \$ 250.00 and a bid bond for 5% of the bid. The bids are for the year 2012 through 2016. For trash and garbage, year one, \$ 220,608.00, year two, \$ 227,667.00, year three, \$ 234,953.00, year four, \$ 244,821.00 and year five \$ 255,103.00.

Recycling bids for year one, \$ 28,800.00, year two, \$ 29,722.00, year three, \$ 30,673.00, year four, \$ 31,961.00 and year five \$ 33,303.00.

Bulk waste collection amounts for year one through five are included with the trash amounts quoted.

Mr. Catania and Mrs. Peterson thanked everyone who participated and stated the bids will be referred to Council for review.
